## **The Humane Society of Broward County:**

- Is a non-profit 501(c)(3) organization (Tax ID# 59-6002321)
- Is a 33,000 square foot, completely air-conditioned shelter
- Can house 300+ dogs, puppies, cats, kittens and bunnies
- Placed over 4,300 animals into homes last fiscal year
- Receives over 250,000 visitors to the facility annually
- Has full-time internal veterinary services with an on-site clinic and staff
- Is recognized nationally as a "leader in animal welfare in the southeastern United States"



## PAWS, an auxiliary of the Humane Society of Broward County

PAWS was founded in 1997 and is an auxiliary of the independent non-profit organization, the Humane Society of Broward County (HSBC). HSBC is not affiliated with any other Humane Society or any national or local animal welfare groups. The shelter relies entirely upon private donations, grants, bequests and fundraising events to care for the more than 30,000 animals the HSBC provides services for each year. Funds raised from special events help the Humane Society of Broward County continue to provide the following programs and services.

# Programs & Services Supported by

**Below are just a few of the many programs and services supported by the PAWS Gala:**

### Education

- Education programs reach over 150,000 children and adults each year through partnerships with Boys & Girls Clubs of Broward County, Girl Scouts of Broward County, local public and private schools (including schools that educate mentally challenged children and adults), Broward County Libraries, Women In Distress & Broward Sheriff's Office.
- Humane Education is part of the grade K-5 science curriculum in the Broward County School System.

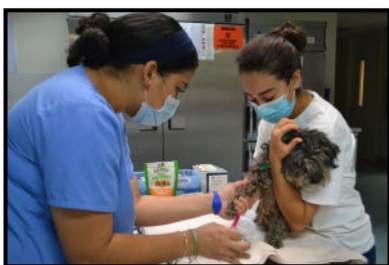


### Surrender Prevention

- Assistance is provided to pet owners in many different ways as an alternative to surrendering the family pet.
- Families are offered simple medical/dental care, along with care for more serious health issues that might require x-rays and/or surgery, pet behavior assistance, donation of food, and more.

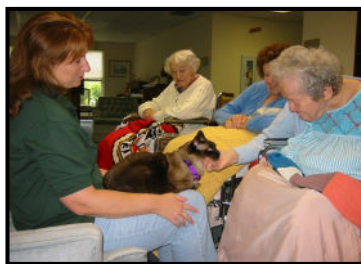
### Low Cost Vaccine Services

- Low cost vaccinations available for the pets in our community



### Spirit Airlines' Mutts and Meows for Military Program

- Helps connect dogs and cats in search of forever homes with veterans who may be battling post-traumatic stress or traumatic brain injuries. These conditions can cause debilitating symptoms in veterans, leading to depression and social isolation.
- A pet's ability to read emotions, provide stress relief, and act as a companion plays an integral role in helping to harness the healing power of the human-animal bond.
- The program provides waived adoption fees and essential items such as leashes, collars, crates & toys for veterans in search of a companion.

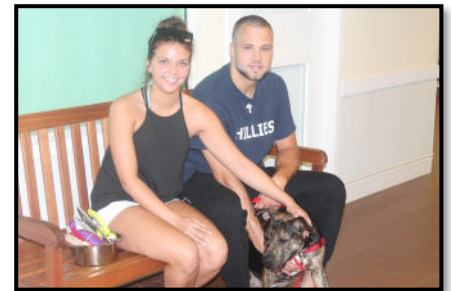


### Animal Assisted Therapy

- Volunteers and their animal assisted therapy pets visit nursing homes, hospitals, children's wards and other facilities throughout Broward County.
- Visits from four-legged friends have been proven to raise the spirits of children and adults of all ages and stages of care.

### Adoptions

- Over 4,300 animals were placed into loving homes or reunited with their owners in 2023.
- Adoption counselors help match the right pets with prospective adopters.
- Companion animals enrich the lives of humans in many ways and research even shows that pet owners have less illness and tend to be more content than others.



### Behavior & Training

- A wide range of Positive Reinforcement training classes are available.
- Free Behavior and Training Handouts are available to the public in both printed and digital formats.
- The Behavior Helpline offers assistance to people having issues with their pets and helps make it possible to keep companion animals with their loving families.
